ADOPTION CONTRACT

from Yadid'It! Dog Training, LLC (Yadid'It!). I agree to the following:

1. This pet's background and temperament, as known by Yadid'It!, have been discussed with me. However, Yadid'It! cannot make any guarantees or warranties regarding this pet's future behavior or condition. I hereby release Yadid'It! from any and all loss, damage, expense, claim or cause of action arising out of or relating to this pet or to any of Yadid'It!'s efforts to facilitate the rescue and adoption of this pet.
2. I have been given a record of this pet's medical history, as known by Yadid'It!. I understand that this pet has received veterinary care through the Yadid'It! adoption program but that undiagnosed conditions sometimes exist. I understand that if this pet is diagnosed with a previously undiagnosed condition that existed at the time of adoption I may return this pet to Yadid'It!, within 30 days, for a full refund of the adoption fee or keep this pet, and assume full responsibility for its treatment.
3. I agree to provide the care and attention necessary to ensure this pet's health and well-being, including:
  - a. Adequate, quality food and water;
  - b. Primarily indoor shelter;
  - c. Daily exercise;
  - d. A martingale collar with rabies tag, identification tags and any necessary: license;
  - e. Emergency and routine medical care, including an annual examination by a licensed veterinarian, vaccinations and/or boosters; heartworm prevention and any other care as may be recommended by this pet's veterinarian, the medication, if any, being prescribed for this pet and instructions for their use are listed in the attached Addendum;
  - f. Mandatory attendance at six weeks of group obedience course, which is included in the adoption fee.
4. I represent that I am adopting this pet as a companion and personal pet, and this pet will be maintained by me at my primary residence at the address listed below and that this pet will not be kept chained.
5. I represent that I do not live on leased property where pets are not allowed; I further represent that the adoption of this pet will not violate any rule of my landlord regarding the number, nature or size/weight of the pets I may maintain at my residence and that I have paid or will pay in full any pet deposit and/or pet rent as required by my landlord.
6. I agree to obey any applicable vaccination and leash laws and to obtain and maintain any licenses or permits relating to this pet as required by law,
7. I agree to allow a representative of Yadid'It! to visit my residence at reasonable times to ensure that the terms of this contract are being met.
8. If, at any time, I find that I cannot keep this pet, I will contact Yadid'It! for assistance with rehoming the pet. Under no circumstances will this pet be abandoned, sold or given over to an animal shelter or to any other person, without first contacting Yadid'It! and speaking to a Yadid'It! representative for rehoming assistance. Yadid'It! reserves the right, in its sole discretion, to bring this pet back into the Yadid'It! program, if I cannot keep this-pet. Yadid'It! reserves the right to limit refunds of the adoption fee to a period of fourteen (14) days following adoption.
9. I understand that noncompliance of any provision of this contract will constitute a breach of contract and that, as a remedy of such breach, in addition to any other available remedy, Yadid'It! shall have right to demand the immediate return of this pet and its medical record.
10. I understand that this is an adoption contract and not a contract for the sale of this pet. This contract and the application I submitted to Yadid'It! constitute the entire contract for the adoption of this pet, and no prior oral representations or agreements are of any force and effect unless incorporated herein.
11. I represent that I am at least 18 years of age and that I have read this entire contract and, understand all of the representations and conditions incorporated herein.
